## **Oceanside Graphics (McDonald)**

- Designs for cafeteria and board room syndicated and approved
- Moving to execution phase
- Immaterial from budget perspective

#### South School Playground and Garden Initiative (Saucier)

Reviewed planned initiative to upgrade the South School Playground and introduce an outdoor learning area. The initiatives will be funded by combination of private funds, grants and RSU (infrastructure).

Drainage and icing are issues on the designated land. Superintendent acknowledged that this is an RSU13 responsibility and will therefore call upon relevant experts to assess the situation. Potential to use SRRF/ADA funds.

Overall concept approved and applauded. Task force to revisit once we have more information, but fund-raising efforts should proceed on assumption that this will move forward.

### **TGS Latest**

- Siemens has presented an RSU13-wide energy proposal. Team will be assembled to review.
- SunDog presented a solar proposal for the TGS roof (net's ~190K over 30 years). No action at this time, but helps with the overall assessment.
- Building-specific SRRF discussed. No action, pending report from Business Manager.
- Superintendent advised that we need to proceed methodically with TGS, and with caution, given potential to overwhelm available resources with project activity.
