MINUTES RSU 13 SCHOOL BOARD MEETING THURSDAY – NOVEMBER 2, 2017 MCLAIN SCHOOL 6:30pm

- 1. Call to Order and Declaration of a Quorum The meeting was called to order at 6:30 PM and quorum was declared. Chair Roberts, Ron Gamage, Nancy Jeffers, Tom Peaco, Susan Allen Thomas, Gerald Weinand, and Loren Andrews were present. Carol Bachofner and Jesse Butler were absent. One Thomaston seat remains unfilled.
- 2. Pledge of Allegiance The Pledge of Allegiance was conducted.
- 3. Adjustments to the Agenda *None*
- 4. Public Participation: Citizens are welcome to speak to agenda matters before the Board (up to 30 minutes total) None
- 5. Presentation
 - A. Social/Emotional Learning John McDonald, Loren Andrews and Jess Yates Superintendent McDonald, Board member Loren Andrews, and Special Education Director Jessica Yates gave a presentation about the benefits of social emotional learning within RSU 13.
- 6. Consent Agenda
 - A. Approval of the minutes of the meetings of October 5, 2017 and October 19, 2017- *Hearing no objections, the consent agenda was acknowledged.*
- 7. Business Items
 - A. Fiscal 17 Budget Transfers Nancy Jeffers moved, pursuant to Section 1485(4) of Title 20–A of the Maine Revised Statutes, that this Board transfer \$225,000 from Article 5, Student and Staff Support to Article 2, Special Education AND \$170,000 from Article 1, Regular Instruction to Article 7, School Administration in the fiscal year 2016-2017 budget. This motion was seconded by Ron Gamage and carried unanimously, of those present.
- 8. Communications *None*
- 9. Reports
 - A. Report of the Superintendent Superintendent McDonald began his report with a recap of the Maine School Management Association Conference held on October 26th & 27th. He participated in some great sessions and came away from the conference with a lot of good information. Next, he advised the Board that school was cancelled October 30th (and again on October 31 for Cushing Community School) due to the windstorm that brought widespread power outages to Maine. RSU 13 sustained very little damage. He then updated the Board about the Thomaston Planning Board meeting he attended on October 17th. There will be a second meeting scheduled for later in November, but Mr. McDonald anticipates approval for the design at Oceanside Middle School. He concluded his report with a reminder of the Strategic Plan Committee Meeting, scheduled for Monday, November 6th at 8:00 am, and is open to the public.

- B. Report of the Business Manager –Business Manager Peter Orne started his report with an update as to the progress at the new Owls Head elementary school. He said to expect weekly updates from that building committee from here on out. He then updated the Board on some regionalization efforts being made by RSU 13 and neighboring districts, such as transportation for homeless students. There is a meeting scheduled for Monday, November 6th, to discuss ways to make these services as efficient as possible.
- C. Report of the Board Chair Chair Roberts also spoke about the Maine School Management Association Conference, and the sessions that he attended. Next, he reported that mediation for negotiations has been rescheduled for November 9, 2017. He stated that the Board is working hard to get a fair pay agreement that brings up early and mid-career people to a fair pay scale.
